PRODUCT DESCRIPTION

Sika® Non-Slip Showerproof Tile Adhesive is an acrylic based, thin bed tile adhesive for extra slip resistance and grab. Designed for general purpose use in bathroom and kitchen areas, it's ideal for securing ceramic wall tiles and mosaics to most interior wall surfaces. Easy to trowel with a good wet edge. This product is a blend of limestone fillers, clay and acrylic polymers with minor additives.

USES

- For fixing all types of ceramic wall tiles including mosaics, porcelain and vitrified tiles.
- Suitable for internal locations such as domestic bathrooms, kitchens and shower areas.
- Can be applied to gypsum plaster, plasterboards, cement fibre board, existing tiles, concrete, cement render, timber panels and plywood boards.

Layer Thickness	3-6mm
Ambient Air Temperature	5°C to 35°C
Open Time	20 - 30 mins @20°C
Curing Time	Allow to dry for 24 hours before grouting (72 hours if tiling on non-porous surfaces). Avoid wetting tiles for 48 hours. Showers should not be used for at least 7 days after grouting has been completed.

APPLICATION INSTRUCTIONS

SUBSTRATE QUALITY / PRE-TREATMENT

PLASTER

New plaster must be a minimum of 4 weeks old before tiling. Tile onto finishing coat only. Prime with SIKABOND SBR+ diluted 1:3 with water.

PLASTERBOARD/PLYWOOD/CHIPBOARD

Must be braced with seasoned timber at 300mm vertically and horizontally. Use moisture resistant grades. All surfaces and edges must be sealed with SIKABOND SBR+ diluted 1:4 with water.

SAND/CEMENT RENDER

Allow at least four weeks drying before tiling. Use a mix design of 3 to 4 parts sand to 1 part cement. Prime with SIKABOND PVA+.

BRICKWORK/BLOCKWORK/CONCRETE BLOCK

Allow at least 4 weeks drying time before rendering or plastering. Do not fix directly to blockwork.

EXISTING GLAZED TILES/FORMICA

Roughen surfaces with abrasive sander and prime with SIKABOND PVA+ diluted 1:1 with water. Apply adhesive whilst still tacky. Allow at least 5 days before grouting.

PAINTED SURFACES

Not recommended for direct application to emulsion or limewash paints. Remove loose material and prime with SIKABOND PVA+ mix diluted 1:3 with water.

For gloss paints, degrease and score with knife to provide key for adhesive. Allow at least five days drying before grouting.

Surfaces to be tiled must be clean, dry and sound. Porous surfaces, including plaster, must be primed with SIKABOND PVA+ diluted 1 to 3 with water and allowed to dry before tiling. Allow new plaster to dry at least one month before tiling.

APPLICATION

Apply adhesive to wall at a depth of 3-6mm (no less than 3mm, no greater than 6mm) combing out an area no greater than 1m² at a time. In dry situations, use a suitable notched trowel across the surface of the adhesive before placing the tiles into position and securing with a slight twist action to remove air voids. In areas subject to wet conditions, do not use a notched trowel. Bed the tiles directly into the surface of the adhesive and again, secure with a slight twist action. In both situations, it is good practice to periodically remove a tile and check that at least 75% of the tile is covered in adhesive. If this is not the case, apply fresh adhesive and reposition.

All surplus adhesive must be removed whilst adhesive is still wet using a dampened cloth or sponge, particularly along grout lines.

CLEANING OF TOOLS

Clean tools in water after use. Wash hands with warm water and soap after use.

LIMITATIONS

- Ensure that the correct product is being used for your application.
- Always follow application instructions carefully.
- Only to be used for walls. DO NOT USE ON FLOORS.
- DO NOT USE IN AREAS SUBJECT TO RISING OR PENET-RATING DAMP.
