- Product Marketing (Upload the Product Marketing materials that you will share in your virtual exhibit -Videos, PDFs/Flyers)
- Add Exhibit Hall Raffle Information

Product Marketing Specifications

As mentioned above, your virtual exhibit includes the opportunity to upload videos and digital PDFs for attendees to view and download while visiting your booth. Below are the specifications for your materials.

- PDF/Flyers/Digital Uploads:
 - File Types: .pdf only
 - Max File Size: 10MB
- Video Uploads (You can provide videos in one of two ways):
 - Upload the videos to your company portal
 - File Types Accepted: .mp4, .mov, .avi, .mpg, .mpeg
 - Max File Size: 20MB
 - Video Resolution: 480p, 720p, 1080p. Videos will be downscaled to 720p (HD).
- Link Video If your video is already hosted on a web-based platform, simply provide the link to the video to your Exhibit Hall Manager, Teri Caron -

<u>TCaron@eventPower.com</u> and she will ensure it gets added. No need to download/upload.

- Videos hosted on YouTube or Vimeo will be automatically embedded into the exhibitor virtual booth.
- Videos hosted on other platforms will be made available via a link.

You may provide a maximum of 5 PDFs and 5 Videos for your Virtual Exhibit

Virtual Exhibit Hall Raffle
