NOTICE IS HEREBY GIVEN, that the Board of Commissioners, Palm Beach County, State of Florida, will receive sealed bids from qualified Contractors, at:

until the hour of **2:00 PM**, Local Time, on **Tuesday, August 30, 2016** and said bids will be opened and publicly read immediately thereafter in the conference room, at the above address, on the same day for:

The project consists of a total of three (3) base bid schedules, to construct the improvements associated with the Southside Redevelopment Program Phases 1 and 2. The project includes a new aircraft storage hangar, apron and taxiway asphalt reconstruction, vehicle access roads, parking and driveways, lighting, drainage improvements, electrical and utility improvements including power, communications, water, and wastewater, security fencing and gates, access controls/CCTV security improvements, and landscaping and irrigation. Base Bid Schedule 1 includes landside improvements on the eastside of the airport between hangar rows 100-800 consisting of clearing and grubbing, pavement and utility demolition, power, communications, water distribution including hydrants and appurtenances, waste water collection system including gravity sewer and manholes, drainage improvements, vehicle access roadway and parking including subgrade, lime rock base course and asphalt surface course paving, pavement markings, security fencing and gates, access controls and CCTV, lighting, landscape and irrigation. Base Bid Schedule 2 includes the west driveway access consisting of clearing and grubbing, pavement demolition, utility modifications including power, communications, water distribution including hydrants and appurtenances, drainage improvements, pavements consisting of subgrade, lime rock base course and asphalt surface course paving, pavement markings, security fencing and gates, access controls and CCTV, lighting, and sod restoration. Base Bid Schedule 3 consists of a 9,600 square foot box hangar in row 600 with restroom and utility room, related drainage improvements, water distribution and waste water collection systems, power and communications, mechanical, electrical and plumbing, apron/taxiway reconstruction including subgrade, subbase, lime rock base course, asphalt surface course paving, and pavement markings.

The work must conform to plans and specifications, which may be obtained or examined on or after **Tuesday July 5, 2016**. The Department of Airports is not responsible for the content of bid documents obtained by means other than indicated below:

The potential bidder shall not, for any reason, provide the access data to any other person or entity.

Bid proposals must be submitted on the forms provided by Palm Beach County and accompanied by a bid security in the form of a certified check, cashier's check, money order or a bid bond submitted on the form provided, in favor of Palm Beach County in the amount of not less than five percent (5%) of the bid price.

All bids must be submitted in a sealed envelope as described in the INSTRUCTIONS TO BIDDERS.
